**OFFICE MEMORANDUM**

**Subject:**    Legislation – Vetting chungchang :

Sorkar-in a Policy tihhlawhtlin nan Dan (Act) a siam thin a, he Act hnuiah hian Rules / Regulations etc. te siam a ni ve leh thin. Tin, Act hnuiah kher lo pawh Non-Statutory Rules te siam a ni bawk. Mizoram Sorkar hnuiah Legislative Department hrarpa kan neih ve loh avangin Law and Judicial Department hian Legislative hna zawng zawng hi a hna peng pakhat angin a thawk ve thin a. Duhthusam loh leh tlin tawk lohna a nei ngei ang tih pawh a hriat theih mai. Legislation leh Subordinate Legislation eng pawh buatsaih leh lo endik (vetting) hna hi hahthlak leh a bik a training pek te tan chauh a thawh chi a ni a. Assembly House-ah MLA zahawm tak tak ten an chai thin a nih avangin uluk a ngai em em a ni. Mizoram Sorkar hnuiah Legislative Draftsmen kan neih tlem avang te leh tunhnaia Assembly House-a Bill thenkhat put luh ten duhthu a sam tawk loh avangin Department hrang hrang te thawh hona tha lehzual awmse tih hi Law Department duh dan a ni a, a hnuia mi te hi zawm hram i tum ang u : -

1. Bill leh Rules te leh Amendment proposal tam zawk te hi a phuailuai deuh thin a, Directorate leh Secretariat level a Officer ruat bik ten uluk takin check hmasak thin nise. Proof-reading, grammatical mistake, typographical error, incorrect composition of words etc. te ang endik tur hian legal knowledge leh experience neih a ngailo bawk a, a theh luttu department level-a hetiang chi ho chu siamthat vek nise. Chumi hnuah chauh vetting ti turin Law Department-ah thawn thin ni tawh se. Chutichuan Bills/Rules/Regulations te a lo felfai zawkin vetting pawh a rang thei ngei ang. Hetiang basic corrections siam ngai tam lutuk hian harsatna tam tak a siam a ni. Legislation bakah MOU, Deed of Agreement etc. te pawh heng hian a huam vek a ni.

2. Hetiang bawk hian Amendment proposed a nihin paih tur emaw belh tur emaw uluk taka enfel a ngai a, section leh clause dang khawih (refer) a nei em tih te zirchian ni thin se. A siamthat theih chuan siamthat nghal nise, a harsat deuh chuan Law Department siam that turin chiang taka tarlan nise.
3. Model Bill hmanga Act kan buatsaih a nih pawhin uluk taka buatsaih nise. A pawimawhlo lai te paiah a, a department mamawh mila herrem thin nise. Words by words-a enfel vek nise a duhawm hle.
4. Hetiang hnuah Law Department-in a exam hnuah correction siam ngai leh siamthat ngai dang te awma thawnlet a nihin Dealing Assistant kutah emaw Computer Operator kutah emaw dah mai lovin a changtu Officer ten uluk taka enpui ziah tur a ni. Hetiang a mawhphur tur bik Officer hi Directorate leh Secretariat-ah Department tin ten an remchan dan angin ruatbik nei se, mawhphurtu an ni nghal ang.
5. Act tam zawk hnuiah hian chu Act ruahmanna tihpuitlinna turin Rules siam a ngai thin a, heng Rules te siam a nih leh nih loh department tin ten in check ila, Rules siam ngai si siam loh a nih chuan a rang thei ang bera buatsaih nise.
6. Act reng reng hi Welfare Legislation a nih ngawt loh chuan prospective effect tur a ni a. Department tam takin Act an published hnuah Act then khat chuan a hman hun tur (effective date) Notification a chhuah an phut thin a. Chutianga a effective date Gazette-a notify si lova a Act hmang ta hmiah hmiah mai an awm thin a, hei hi thil awmze nei lo leh tih loh tawp tur a ni. A hnuah regularize tur a Law Department-a ngen phei chu tih miah loh tur a ni. MOUs/Agreements etc. te signed (executed) tawh hnu Law Department a vet tur ngen te a awm thin, hei

hi thil awmze nei lo a ni bawk. Hetiang chi hi Law Department-in a regularize thei lova, thuneihna a nei hek lo. Department tin te hetiang thil hi a awm em tih in enfiah nghal nise, a tul apiang a rang thei ang bera tih ni rawh se.

Dan leh dan tesep hrang hrang siam leh buatsaih kawngah te leh vetting chungchang ah te department tin-in ngaihtuahna thar hmang leh ila. Democracy ramah chuan Sorkar Policy tihlawhtling turin Dan leh Dan tesep dangte hmang a hnathawh thin a ni tih hre thar leh ila, thahnem ngai leh zualin department tin te i han in sangmar teh ang u.
