**No. A. 12011/32/2016-LJE :** In the interest of public service, the Governor of Mizoram is pleased to create Champhai Judicial District in the State of Mizoram comprising of the areas covered by the existing administrative districts of Champhai and Khawzawl with immediate effect.

Consequent upon the constitution of Champhai Judicial District, the territorial division of Judicial Districts are as follows:-

- 1) Aizawl Judicial District comprising the areas covered by the existing administrative districts of Aizawl, Kolasib, Mamit, Serchhip and Saitual.
- 2) Lunglei Judicial district comprising the areas covered by the existing administrative districts of Lunglei, Lawngtlai, Siaha and Hnahthial.
- 3) Champhai Judicial District comprising the areas covered by the existing administrative districts of Champhai and Khawzawl.

This issues with the approval of the Hon'ble Gauhati High court conveyed vide their letter No. HC. VII - 83/2019/4969/A dt. 08.10.2021 and the approval of General Administration Department conveyed vide I.D.No. GAD:490/2021 dt. 01.11.2021.
